- Provide a level of capital growth which at least matches increases in CPI over a 5-7 year time horizon; and
- Provide lower than market volatility<sup>3</sup>.

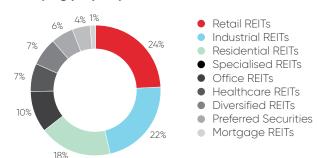

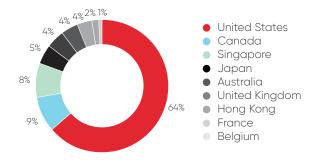
### Underlying property sector allocation 28 February 2023

### Geographical allocation 28 February 2023

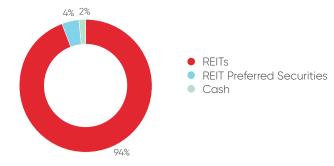
