DEUTSCHE OFFICETRUST ■ Leasing Update

Deutsche Asset Management (Australia) Limited as the responsible entity for the Deutsche Office Trust (DOT), provides the following leasing update.

At **Governor Phillip Tower in Sydney CBD** Merrill Lynch (Australia) Pty Ltd has signed a lease for 5,153 square metres of office space for 10 years and six months, commencing 1 March 2005. Terms have also been agreed with CMC Group Asia Pacific Pty Ltd for 700 square metres on Level 41 for 5 years, whilst Heidricks & Struggles Australia, which occupies 871 square metres of space on level 28, has re-signed for a further 7 years.

Following on from the recent leasing success at **The Zenith, Chatswood**, PeopleSoft Australia Pty Limited has leased 4,500 square metres of office space in Tower A for 5 years commencing 1 February 2005. In addition, a lease has been executed with Transport Infrastructure Development Corporation over a further 1,000 square metres, removing the majority of vacancy in the complex.

At **Woodside Plaza in Perth**, Woodside Energy have agreed terms for an additional 2,143 square metres on Level 12 for 5 years commencing 1 October 2004, leaving less than 800 square metres available to lease in the building.



Over 1,000 square metres of new deals were concluded at **O'Connell House, Sydney** during the June quarter, leaving only 1,700 square metres to lease in the building.

The recently refurbished Plaza Building at **Australia Square** in Sydney CBD has attracted two new tenants with Project Control Group Pty Ltd and Johnson Pilton Walker Pty Ltd agreeing terms for a floor of 783 square metres each in the building.

In the western corridor of the Sydney CBD, the NSW Government has renewed its tenancy over 2,380 square metres at **45 Clarence Street** for a further 5 years. In addition, WHK Services Company Pty Limited has leased an additional 1,149. square metres at **Lumley House** for 4 years and 3 months.

Michael Brown, General Manager, Deutsche Office Trust said "The Trust's active leasing strategy and tenant management continue to boost occupancy levels and minimise downtime across the portfolio."

"Whilst significant leasing challenges remain over the next 12 months I am confident that a more positive outlook for office markets, particularly in Sydney, will lead to further deals in the future," said Mr Brown.

As a result of the above lease transactions the Trusts lease duration profile has been maintained at 5.8 years.
