## **FY18 Financial Results**

APN Funds Management Limited as responsible entity for the APN Regional Property Fund (the **Fund**) is pleased to announce the Fund's full year financial results for the year ended 30 June 2018.

## Key Highlights:

- Net Profit of \$8.22 million;
- Net tangible assets increased 18.2% to \$1.41 per unit;
- Distributions per unit of 9.5 cents were paid, consistent with the prior reporting period;
- The Fund's weighted average lease term to expiry (WALE) was 1.9 years (by income);
- The Fund's loan to valuation ratio decreased from 33.1% to 29.4% as at the reporting date; and
- The Fund's portfolio was independently valued as at 30 June 2018 as follows:
